Learn about the upcoming hearings.

<u>During the week of 2/15, MAJR priority bills will have important committee hearings.</u>

These include:

Monday, 2/15,1:30pm (House Judiciary). HB1035 would provide for independent investigation and, if appropriate, prosecution when police officers shoot or otherwise cause violent deaths to Marylanders. This would replace the current system where local State's Attorneys must prosecute the same officers who work with them every day.

Tuesday, 2/16, 1:30 pm (House Judiciary). HB0032 would legalize marijuana use for adults in Maryland, as well as providing safe regulations comparable to those for liquor sales, and tax revenue dedicate to health, safety, education and the general fund. Alcohol prohibition's repeal resulted in huge drops in crime and law enforcement costs; this bill will bring the same needed changes for marijuana -- scientifically found less dangerous than alcohol.

Wednesday, 2/17, 1:00pm (Senate Judicial Proceedings-JPR). SB0494, the *Juvenile Restoration Act*, is designed to abolish the sentence of *Juvenile Life Without Parole* and permit a person who was convicted of a crime committed while the person was a minor to file a motion for a sentence reduction. This bill supports the belief that no child is beyond the hope of redemption. We join The Campaign for the Fair Sentencing of Youth and other advocates in support of this bill.

<u>During the week of 2/22, MAJR priority bills will have important committee hearings.</u>
These include:

Tuesday, 2/23, 1:00 p.m., (Senate JPR). SB0742 will require a study of other states' successful *Model Prison* programs that offer education, structure, peer mentoring, and other best practices to drastically improve outcomes in reduction of prison violence and recidivism. Maryland needs to change the basic culture of its prisons to be restorative, rather than punitive!

Tuesday, 2/23, 1:00 p.m. (House Judiciary). Various expungement bills will be considered. Maryland currently offers very limited and burdensome procedures to remove public records, despite ex-offenders having completed their sentences and established lengthy good behavior.HB0238 and HB0882 offer useful steps towards a fresh start for Marylanders who have rehabilitated themselves.

Thursday, 2/25, 1:00 p.m. (Senate JPR), SB0671permits police the option to issue citations, instead of arrest, for nonviolent misdemeanors such as simple drug possession, when appropriate. Supported by the Maryland State's Attorney's Association and Maryland Chiefs and Sheriffs, this bill would reduce pretrial detention population, costs, COVID-19 risk, and add more time and efficiency for police.
