2022 LEGISLATIVE INITIATIVES

Front Door:

Juvenile Justice Reform: The Juvenile Justice Reform Council, with the assistance of the Vera Institute of Justice, has researched best practices regarding the treatment of juveniles who are subject to the criminal and juvenile justice systems. MAJR supports those recommendations. In addition MAJR supports the Juvenile Interrogation Protection Act identifying practices that have been shown to pressure children into false confessions. <u>HB1187</u>, <u>SB136</u>

Marijuana legalization: When Prohibition of alcohol was repealed in 1933, crime dropped, law enforcement costs dropped, safe regulation was possible, and substantial tax revenues became available for the public good. Legalization of marijuana will bring the same opportunities and need for precautions. On balance, MAJR strongly supports the Maryland General Assembly leaders' proposal to reduce Maryland's misuse of criminalization and incarceration for this public health concern, as well as to provide needed tax revenue. https://www.ma4jr.org/marijuana/

Motor Vehicle Laws - *Decriminalize Driving While Poor*. In Maryland, driving uninsured or without a valid license is an incarcerable offense or up to one year in jail, a \$1000 fine, or both for the first offense. Yet over 500,000 Marylanders drive uninsured throughout the state of Maryland citing the cost of auto insurance as the primary factor.. JOTF believes that an individual's poverty should not determine their mobility and is pursuing legislation to eliminate incarceration as a penalty of driving uninsured or on a license suspended for child support. <u>See JOTF initiatives</u>.

Behind the Walls:

Correctional Ombudsman Office: Without independent oversight, Maryland prisons face chronic problems involving individuals' health & mental health, education, etc. – the COVID crisis unmistakably has demonstrated the need for greater transparency. The Ombudsman concept has been endorsed by Gov. Larry Hogan: Cutting through layers of bureaucratic review now required, Maryland could join several other states with an independent Ombudsman to publicly report and recommend improvements as to the individual's needs, as well as those of prison volunteers and families. https://www.ma4jr.org/ombuds/

Direct Release from Solitary. Joining with the Interfaith Action for Human Rights (IAHR), MAJR supports changes to DPSCS procedures so that incarcerated individuals are not released directly from solitary to their community. The proposed "Step-down program" has been designed to implement these changes. See our testimony on the 2021 legislation.

Back Door:

Expungement: Work with the Job Opportunities Task Force (JOTF) to support the REDEEM Act and other expanded expungement laws. See <u>http://www.ma4jr.org/expungement-unit-rule/</u>

Collateral Consequences

Removing Barriers to Employment. Backdoor plans to work with the MGA Reentry Workgroup to propose bills that remove barriers to occupational licensing, business licensing, and direct employment as well as creating incentives for businesses to become second chance employers. Maryland REDEEM Act of 2022 A criminal record can easily be both the cause and consequence of poverty. The appearance of a criminal record in a routine background check can, and many times will, block access to employment, education, housing and occupational licensing- all of which are necessary to advance in Maryland. JOTF seeks to expand access to criminal record expungement for the 1.5 million Marylanders with a criminal record by allowing nonviolent misdemeanor and felony convictions to be eligible for expungement. <u>See JOTF initiatives</u>.
