Judith Sachwald served as Maryland's Director of Parole and Probation, leading over 1,300 employees who provided supervision to approximately 69,000 individuals under probation, parole, mandatory supervision or home detention.

She guided the development and implementation of a research-based approach to supervision which holds offenders accountable for their actions while assisting them in becoming law abiding, responsible and productive. Under this new approach to supervision, offenders were 38 percent less likely to be arrested or violate the rules of supervision.

## Correctional Ombudsman

It's time to find out where your candidates for Governor stand!
